BOARD OF SELECTPERSONS MINUTES

The Board of Selectpersons held their monthly meeting on Tuesday, April 16, 2024, at 6:30 p.m. at the Troy Municipal Office.

1. The meeting opened at 6:30 pm.
2. (a) Steve reported the service line inventory project has been approved by the State.
(b) The ferric Chloride pump needs replacement.
(c) Water meters have been read and the 2023 Consumer Confidence Report was inserted in all new water bills.
(d) Steve ordered 4 Sensus meters from EJ Prescott before they stop handling Sensus products.
3. Jenn Harlow from the Orleans County Sheriff's Office signed the Sheriff's Contract for 2024. A motion was made by Gaston to sign the Sheriff's Contract that covers April 1, 2024-March 31, 2025, in the amount of \$20,130.00.
4. (a) Jim Brewer spoke to the board regarding his class 4 road off Bear Mountain. There has been a problem with Illegal immigrants entering from Canada at the end of the road. He asked to put a gate just past the last homeowner. The board told him he could do that. Mike is going to go look at a damaged culvert with Jim tomorrow.
(b) Mike reported mud season was done. All roads are in good shape. He did not feel that the Rasputitsa bike event would hurt the roads.
(c) The road crew has been getting some gravel from the Starr's Pit for Veilleux Road.
(d) The 2025 Grants-in-Aid application was discussed. Terri will apply for it for work on Veilleux Road.
Roger Morin told the board what he has planned for projects this summer in the Troy cemetery. He will purchase staymat to use under the stones that have fallen over. He has enough wet & forget for this summer. He plans to redo many stones in the Kay Division.
Holly Pepin spoke to the board about her interest in being on the Cemetery board. A motion was made by Gaston to appoint Holly Pepin, with

appreciation, to the Troy Cemetery Board, replacing Grace Crane, who passed away.

5. Sarah Standish spoke regarding barking dogs that are left outside in a pen next door, on Dominion Avenue. She asked about a barking dog ordinance for the Town of Troy. Gaston will look into it and report back at the next meeting.
6. A motion was made by Anne to approve the minutes of March 18, 2024.
7. Gaston reported that the new town website was launched. Anne thanked Terri and Gaston for all of the work done getting it completed.
8. 2 liquor licenses for Post #28 American Legion were approved.
9. The 2024 Local Emergency Management Plan was reviewed, and a motion was made by Robert to adopt the plan.
10. All Orders were approved.
11. Overweight permits were signed by Robert.
