1. The Meeting opened at 6:32 PM
  2. Steve has been spending some time looking for grant funds for the water project. He has also met with Gaston and a representative from the SRF Funding regarding funding the project
  3. Mike did not attend the meeting. He has been dealing with the flooding.

7. The board began having a conversation about merging the Village of North Troy with the Town of Troy. Gaston has searched for other towns that have merged in the past and he will bring the information to our next regular meeting.
8. Minutes of February 18, March 4 and the Annual Meeting of March 4, 2025, were approved by a motion made by Gaston.
9. All warrants were signed.
10. 14 Overweight permits were signed by Robert.
11. Gaston brought a Letter of Support for the Vermont Community Broadband Board. The board reviewed and signed the letter.
