Annual Meeting Minutes  
March 3, 2026**

**TOWN MEETING:**

Terri Medley opened the meeting at 11:55 AM.

- 1) Gaston Bathalon was elected moderator for the ensuing year. (Robert Langlands)
- 2) Town Officers' reports were accepted as read. (Roland Mayhew)
- 3) Election of officers, as follows:
  - a. Selectboard Member – Robert Langlands – For a three-year term (Gayten Verge)
  - b. Delinquent Tax Collector – Terri Medley – for a one-year term (Gayten Verge)
- 4) The voters appropriated \$306,063 for the General Fund Budget for 2026 adjusted with the approval of the numerous appropriations ensuing in the Warning. (Gayten Verge)
- 5) The voters appropriated \$802,013 for the Road Budget for 2026. (Roland Mayhew)
- 6) A motion was made by Robert Jacobs to approve all appropriations totaling \$233,727.07, and the appropriations were accepted as follows:
